**NOTICE REGARDING MOTION
FOR FINAL APPROVAL OF
SETTLEMENT**

16 Plaintiff's motion for final approval of the class action settlement is set for hearing on
17 November 8, 2019. The Court set the hearing in November so that it would take place after the
18 deadline for class members to submit claims, request exclusion from the settlement, or object to
19 the settlement ("Claims Deadline"). The Claims Deadline is September 17, 2019, per the
20 Court's order granting preliminary approval of the settlement. Plaintiff's motion for final
21 approval will report on the rate of claims and the number of requests for exclusion or objections
22 received from class members. Accordingly, it should be filed after the Claims Deadline. Due to
23 counsel's scrivener's error, however, the preliminary approval order sets a due date of
24 September 3, 2019, for Plaintiff to file her motion for final approval of the settlement. Plaintiff
25 will file her motion no later than October 4, 2019, which is after the Claims Deadline and more
26 than a month before the hearing on the motion.
