Accordingly, it should be filed after the Claims Deadline. Due to 22 counsel's scrivener's error, however, the preliminary approval order sets a due date of 23 24 September 3, 2019, for Plaintiff to file her motion for final approval of the settlement. Plaintiff will file her motion no later than October 4, 2019, which is after the Claims Deadline and more 25 26 than a month before the hearing on the motion. 27
